

POWER OF ATTORNEY

DECLARATION

DO HEREBY AUTHORISE and APPOINT (the “Agent”) to be my lawful agent and I confirm that my agent has authority to transact and manage my account(s) and or investment(s) in any manner he/she deems appropriate, including but not limited to:

1. Opening and closing of bank accounts and opening and closing of accounts with virtual currency exchanges locally and internationally.
2. Authorising payments, repurchases and or withdrawals and trading.
3. Re-investing any accruals, income, dividend and/or interest received by me.
4. Transferring or giving up my right to any legal benefit.
5. Accessing statements and information from banks and exchanges.
6. Exercising all rights that I myself have in relation to my accounts and investments with banks and exchanges.
7. Signing all necessary documents to give effect to any of my instructions.
8. To represent me before any bank that is authorized as Authorised Dealer for purposes of the Exchange Control Regulations.
 - 8.1 To open bank accounts and exchange accounts in my name; and
 - 8.2 To deposit and withdraw amounts in cash or transfer part or the total balance on the account(s) and/or to close such account(s).
 - 8.3 To trade in virtual currencies and other currencies in unlimited value and volume subject only to the limit of the single discretionary allowance per calendar year available to me as an individual South African resident.
9. To trade in virtual currencies in the Republic of South Africa and abroad through various trading platforms and exchanges and to make use of payment services providers and banks and exchanges.
10. To settle transactions and settle current or future financial obligations, to hold funds on virtual accounts and to convert virtual currencies into other currencies (real money) and vice versa and in general the agent is authorised

to conduct all activities related to the acquisition, trading and use of virtual currencies.

11. To perform any legal and factual actions not explicitly mentioned in this Power of Attorney but having relation to any of the aspects and actions described hereinbefore and/or in execution of the profit share agreement entered into between the agent and myself (the principal) to enter into any agreements, validly binding me with his/her signature, including to act as an agent for partner entities, whether domiciled in South Africa or abroad for the purposes of enacting transactions and obtaining information from the banks referred to in paragraph 8 and elsewhere hereinbefore, regarding balances on the accounts at the said banks or at exchanges opened in my name, to receive, sign and submit any requests, applications and other documents, including declarations of origin of funds in matters prescribed by law, in the exercise of the rights under this Power of Attorney.
12. If necessary the agent is allowed to obtain a credit check in my name.
13. The agent shall receive compensation for services and reimbursement for expenses rendered and will be paid the amount agreed to between myself and the agent.
14. The powers conveyed by this Power of Attorney shall become effective from date of signing hereof and will be in force and effect for a period of 12 months from date of signing hereof.
15. I indemnify and hold harmless my agent from any loss that results from any error made in good faith.
